## 15:00-16:30 Thematic Session 1: Sustainable transport for the achievement of the SDGs in LLDCs

This session will focus on the specific challenges of LLDCs and the importance of developing efficient and sustainable transport in LLDCs for their sustainable development. Sustainable transport and infrastructure is not only directly referenced in SDG 9 and SDG 11 but is also expected to contribute to the implementation of many other SDGs. Efficient and sustainable transport also plays a particularly significant role in addressing climate change, whose effects the LLDCs are particularly affected by. Despite improvements in transport infrastructure development in LLDCs, poor quality, inadequate services and missing links in physical infrastructure hinder LLDCs' efforts in developing efficient transport systems. The session will focus on sustainable transport, including all modes (roads, rails, bridges, seaports, dry ports and air transport) and in both rural and urban contexts.

16:30-18:00	Thematic Session 2: Enhancing efficient transit transport systems for economic growth and greater participation of LLDCs in regional and global trade	
	This session will focus on the development of efficient and sustainable transit transport systems, in particular transit and economic corridors. Closing the missing links in transit transport networks in regions with LLDCs is critical to improve connectivity and competitiveness, reduce transport costs, and enhance their integration into the global trading system. Close cooperation of LLDCs and transit countries in their respective regions on transport is a necessity in this regard. In this session, participants will share experiences and best practices on transport and transit-related regional infrastructure development, including completing missing links connecting LLDCs within regional networks and development and enhancement of all aspects of corridors in order to enhance access and stimulate economic development.

The discussion will include topics such as harmonization and simplification of border crossing rules and procedures, accession to legal instruments on trade and transport facilitation, trade facilitation, freedom of transit, amongst others.

This will include the importance of engaging in and benefitting from international mechanisms and fora such as climate funds, the Global Infrastructure Forum and the Global Sustainable Transport Partnership, among others.
